Figure 1. A schematic diagram of the experimental setup. The light source (laser) emits a beam of light that passes through a lens and a polarizer. The beam then passes through a series of optical components, including a beam splitter, lenses, and mirrors, before being focused onto a sample stage. The sample stage holds a sample of material, which is illuminated by the laser beam. The reflected light from the sample is collected by a lens and directed into a spectrometer. The spectrometer measures the intensity of the light at different wavelengths, which is used to determine the properties of the sample.
